# **Welcome and Opening Prayer** (1 minute)

#### **Introduction** (2 minutes)

- Review Tri-Fold Summary
- Describe the process to prepare for a vote on juncture:

- "I hope you have all had the chance to review the Building Bridges Report to Convention and the Frequently Asked Questions document that were distributed earlier.
- "We will share a QR code to access the documents about juncture after today's discussion, so that you can read up on the issues surrounding this decision.
- "We hope we can answer your questions today, but we may need to take some of them back to the Building Bridges team for consideration—we will add responses to the FAQs document, as we develop responses."
- The leadership of the two dioceses and Building Bridges team are holding four sessions, both in person and online, starting January 20th to hear feedback on the summaries of the proposed recommendations of the canons and transitional budget for 2025.
- "Finally, having incorporated feedback received from many sources in early February, the Building Bridges Steering Committee will share the actual draft canons and other content that will be included in the Agreement for Union, so that everyone, most especially the convention delegates, can review them before the pre-Convention meetings on February 20th for Eastern Michigan and February 22nd for Western Michigan."

### **Questions** (50 minutes)

"Today, we want to ask you some questions, so that we can hear your thoughts about this pending decision.

- What do you know about the issue of juncture between the two dioceses?
- What do you like about the idea of juncture?
- What concerns you about juncture?
- What additional information would you need to make a decision?

- "Thank you for joining us today."
- "We will share your responses with the Building Bridges team, so that they can prepare us for the Special Convention."
- "Please encourage other people in the congregation to read through the materials and learn as much as they can about this process."
